Preference will be given to returning vendors. Spaces will held for returning 2009 vendors until June 1, 2010. Food vendors will be assigned spaces depending on power/water requirements and availability. Payment must be received in full by June 1st to maintain your space at our 2010 rally. After June 1st spaces will be awarded on a first come basis. If you are a new vendor or food vendor, please contact the vendor coordinator prior to mailing contract or money to ensure vender spaces are still available. Set up time is no earlier than 9:00am on July 28, 2010 and stay no later than 2:00pm on Aug 1, 2010. Vendors will be provided 3 free wrist bands for employees/family, etc., but will have to pay admission fee for any additional wrist bands. Food vendors **must provide and maintain their own trash can.** Vendors are responsible to provide their own power cords/plugs.

Vendors will be required to complete and file form ST-124 IDAHO SALES TAX DECLARATION with the state of Idaho within 15 days of the event.
